The sales and Distribution of Sunquick product is handled by C. W. Mackie PLC.

The marketing is a joint effort between brand owner CO-RO Food A/S and C.W. Mackie PLC. CO-RO Food A/S was founded in 1942, and its premium fruit-based brands are soldinmorethan70countries. Operating globally since 1945, it is firmly committed to delivering high quality products of outstanding taste and compelling brand experiences to consumers.

Distribution of Sunquick brand squash concentrate started in 1979 by Scan Products (Pvt) Ltd., in partnership with CO-RO Food A/S, Denmark and the local manufacturing operation began in the year 1999. Since then, Sunquick brand fruit squash concentrate has been the market leader in Sri Lanka. The factory is located in a beautiful setting in Munagama, Horana, Sri Lanka where all products are manufactured.

The squash concentrate is sold in glass bottles in the consumer market and plastic canisters for the catering sector. Sunquick is a high-quality drink made with fruit juice, it contains no artificial colors or flavors and is a source of Vitamin C, A & E. Each bottle of concentrate gives you many liters of delicious refreshing drink, making Sunquick perfect for sharing with family and friends.

The facility produces around 2.5 million liters of fruit squash concentrate drinks innineflavorsin330 ml, 840 ml and 2L package sizes. The company has also introduced a ready to serve drinkin2019in four main flavors. In 2021, the company has expanded their product portfolio and initiated the production of 200 ml and 125 ml ready to serve drinks production in aseptic pack.
